The quotation received after the deadline of submission shall be rejected / will not entertain.
- 2. The rate should be quoted as per the sector, airlines and timing given above.
- 3. The Bidder (s) shall enclose a copy of **valid trade license**, **tax clearance certificate** along with its bid.
- 4. The rates quoted shall not be subject to change for the duration of 5 hours after the opening of the quotation.

- 5. Conditional quotations entailing an increase of fares or change of airlines at the time of travel and offers such as wait lists or offering alternative routes shall not be accepted.
- 6. Bidders should always provide quotes for full fare on "Business and Economy" with **CONFIRMED** seats only.
- 7. Bidders shall quote for **flexible tickets to enable change** and refund in the event of any **unavoidable** circumstances. Cancellation and rebooking charges per ticket may be specifically mentioned, wherever applicable.
- 8. The travel agent(s) is required to quote as per the sectors mentioned above and in the most RELIABLE Airlines with good **COVID-19 safety measures.**
- 9. All rates should be mentioned in our local currency and should be inclusive of all incidental charges of Air service agents (Druk Air or Bhutan Airlines) and if you are the best evaluated bidder, we will contact you.
- 10. Payment shall be made only after availing the travel and only upon submission of duly verified bill.
- 11. The procuring agency reserves the right to award sector-wise to whomever found cheaper besides route and schedule conveniences.
- 12. Bids shall be **rejected** or bidders shall **de-barred** from participating in the bidding process if they are found involved in any form of corruption or in collusion with the client.'
- 13. All the other terms and conditions shall remain the same as specified in the bidding documents or PRR 2023.
